

## **PUW Rates for FY 2023**

The Airport Board reserves the right to set and impose rates and charges for operations at PUW. Rate schedules are subordinate to any current lease agreement held with an entity and the Pullman Moscow Regional Airport. The following schedule details the rates for FY 2023.

1. Landing Fee Scheduled Air Carrier \$1.15 per 1000 lbs MLW.  
    Unscheduled Air Carrier / Charter \$1.75 per 1000 lbs MLW.
2. Landing fees for A/C over 7,000 lbs/ MLW \$1.25 /1000 lbs MLW.  
    Charged to Non- Based Aircraft \$15.00 Minimum Charge
3. Aircraft Parking Fees:
  - Aircraft (<12,500 lbs MTOW) \$5.00 night, \$50.00 month + current leasehold tax and \$325.00 Annual + current leasehold tax
  - Aircraft (>12,501 lbs MTOW) & small Helos (<4,000 lbs MTOW) \$10.00 night
  - Aircraft (15,001-45,000 lbs MTOW) & Helos (4,001-6000 lbs MTOW) \$15.00 night
  - Aircraft (>45,001 MTOW) and Helos ( >6,001 MTOW) \$20.00 / night

Monthly and Annual Parking fees for aircraft over 12,501 lbs and Helos over 4,000 lbs will be evaluated by the airport on a case by case basis factoring size, weight, and available space.

The FBO may collect the Parking Fees from transient aircraft as set by the airport and retain 35% of the fee for handling the collection with the right to offer 2 free days of parking for sale of fuel. Fees so collected will be remitted to the airport each quarter with a record of collection / non collection by N number for billing / audit purposes. Aircraft Fees set by the Airport shall be publicly and conspicuously posted in the FBO. Landing fees shall be collected by the airport or on a contracted basis. Landing and Parking Fees may be waived or adjusted by the airport at its sole discretion (events, fly-ins etc.).

4. Airport Terminal Space – Individually negotiated rate based on area and location.
5. Ground Rate (Aero) .19/sqft/ann. Applies to new leases, transfers and 5 year updates.  
    Non Aeronautical Rate: \$0.35 / sqft / ann.  
    Minimum Agricultural Rate: \$100.00 / acre / ann. (eligible for bid).
6. Hangar Rental (Airport owned) \$185 / mo. + current leasehold tax.
7. Long Term Auto Parking \$10.00 day. (*Board approval on April 24, 2024*).
8. Rental Car Concession Fee and Car Stall Fee – As set by Individual Contract.
9. Fuel Flowage Fee – \$0.08 / Gallon delivered to PUW paid by supplier.
10. Passenger Facility Charge (PFC) no less than \$4.50 unless prohibited by legislation.
11. Badging - \$35.00 AOA, \$70.00 SIDA. Lost Badge Fee \$250.00.

*Current Lease hold tax rate is 12.84%*
